

Disclosure of shareholdings according to the Swiss Financial Market Infrastructure Act: Shareholding of Harris Associates Investment Trust in LafargeHolcim Ltd

In accordance with Article 120 of the Federal Act on Financial Market Infrastructures and Market Conduct in Securities and Derivatives Trading (Financial Market Infrastructure Act (FMIA)), LafargeHolcim Ltd was informed on February 10, 2016, by Harris Associates Investment Trust that it holds, through acquisition of shares, 3.03 percent of the voting rights and of the registered share capital of LafargeHolcim Ltd. This corresponds to 18,412,635 registered shares and voting rights. According to the declaration of Harris Associates Investment Trust, the Stock Exchange Act threshold of 3 percent was exceeded on February 5, 2016.
